



Figure 3.1. WP structure of the MAIA project






#### For economic valuation processes at the national level:

- 1. Is there at least one **nationwide economic value** available **for one ES** in each category (prov., regulating, cultural ES) for communicating broad ES stakes?
- 2. Is at least one **economic value** for one ES in each ES category **mapped at national level** so that localized stakes are properly recognised?
- 3. Are there any **completed or ongoing projects** which have developed or used economic values for informing planning processes at different policy levels?
- 4. Are there actions taken to **include ES values into decision-making processes** or in policy impact assessment (in particular CBA, EIA)?

## For promoting the integration of these values into accounting and reporting systems at EU and national level:

- 5. Is there (at competent governance level) a **NCA committee or working group** which oversees the implementation of NCA in the country or region?
- 6. Are there any **pilot accounts** on economic valuation of natural capital taking place in your country (including the grants from Eurostat)?
- 7. Are any of the following **accounts available at national level**: Ecosystem extent, ecosystem condition, ES (with at least an account for ES) or thematic accounts on biodiversity or carbon?

#### **Possible MAES NCA MAIA Barometer questions**

(answered in MAIA Survey of 2019)

- 1. Are there any completed or ongoing NC Accounts at national level in your country? (meaning a combination of ecosystem extent, condition, ES, thematic accounts)
- 2. Are there any completed or ongoing ecosystem extent accounts at national level? (area of coverage of a given ecosystem type, e.g. land use, land cover or land ownership)
  - 3. Are there any completed or ongoing Condition accountings at national level? (overall quality of an ecosystem asset)
- 4. Are there any completed or ongoing ES supply and use accounts (with at least an account for one service) at national level?
  - 5. Are there any completed or ongoing Thematic accountings of land (use, cover or ownership) at national level?
- 6. Are there any completed or ongoing Thematic accountings of water at national level?
- 7. Are there any completed or ongoing Thematic accountings of carbon at national level?
- 8. Are there any completed or ongoing Thematic Biodiversity accounts at national level? (ecosystem and species-level biodiversity)
